



PRIVACY AND COOKIE POLICY

INTRODUCTION AND REGULATORY REFERENCES

The following Privacy Policy describes how this site is managed with reference to the processing of personal data of users who surf the site.

This information complies with Article 13 of Regulation (EU) 2016/679 (hereinafter: the "Regulation") of the European Parliament and of the Council of 27 April 2016 EC (General Regulation on Data Protection, published on 4 May 2016 in the Official Journal of the European Union, in force since 24 May 2016), Recommendation No 2/2001 that the European authorities for the protection of personal data, gathered in the Group established by art. 29 of Directive No. 95/46/EC, adopted on 17 May 2001 to identify certain minimum requirements for the collection of personal data online, and, in particular, the manner, timing and nature of the information that data controllers must provide users when they connect to web pages, and in light of the Provision of the Guarantor for the protection of personal data of 8 May 2014 entitled "Identification of simplified procedures for the information and acquisition of consent for the use of cookies" (hereinafter, the "Provision") and in compliance with current legislation on privacy.

This information is provided only for this website of which GES International s.r.l. is the owner of the treatment and not for other related websites within this site.

THE DATA CONTROLLER

The owner of the processing of data collected through the website is GES International s.r.l. with headquarters in via G. Di Vittorio 307 20099 Sesto S. Giovanni (Mi)

GENERAL PRINCIPLES ON THE PROCESSING OF USER'S PERSONAL INFORMATION

The user's personal information will be collected, stored, processed and transmitted in accordance with the criteria established by GES International s.r.l. and the laws, rules and regulations in force regarding the processing of data.

The principles relating to the processing of the user's personal information are as follows:

- (1) the personal information of the user will be treated in a correct and lawful way;
- (2) your personal information will be collected for specified, explicit and legitimate purposes and subsequently processed in a manner compatible with those purposes;
- (3) your personal information collected will be relevant, complete and proportionate to the purposes for which it is collected;
- (4) the personal information we collect about you will be accurate and, where necessary, updated to the best of our abilities;
- (5) your personal information will be protected against unauthorised access and processing by commercially and technically reasonable technical and organisational security measures and controls; and



(6) the Personal Information we collect about you will be kept as personal data no longer than is necessary to achieve the purposes for which the Personal Information was collected.

TYPE OF DATA COLLECTED

This Web Site does not explicitly collect personal data requested from the user or particular categories of personal data (ex-SENSITIVE DATA: personal data revealing racial or ethnic origin, religious, philosophical or other beliefs, political opinions, membership of parties, unions, associations or organizations of a religious, philosophical, political or trade union, as well as personal data disclosing health and sex life) or judicial.

Unless expressly requested or specifically requested, we ask you not to send us or disclose sensitive personal information on or through the Website or in any other way. In cases where we may request or encourage you to provide sensitive information, we should obtain your explicit consent.

The site does not keep track of any personal data outside of the navigation data collected within the site and only anonymously, used solely for statistical purposes and on behalf of Google Analytics (for more information go to <http://www.google.it/intl/en/analytics/privacyoverview.html>).

Similar information, such as device type and identifier, may be collected if you access the Website from a mobile device.

This data is used only to obtain anonymous and aggregate statistical information on the use of the site and to check its proper functioning and is deleted immediately after processing. The data could be used to ascertain responsibility in the event of hypothetical and possible computer crimes against the site.

PURPOSES OF PROCESSING

We collect, store and process your personal data for the purpose of providing you with the services offered through our website, i.e. for legal obligations.

The data collected will be used exclusively for the following purposes:

- For an effective management of the Site and the services offered by it;
- To comply with the legal obligations deriving from the fiscal and accounting regulations and from any other regulations in force;

CONFERMENT OF DATA

This site deals only with navigation data, as described above; it does not include any request form for the provision of data by users.

METHODS OF PROCESSING AND DATA SECURITY

Your personal data will be used with the support of paper, computer or telematic means for the purposes indicated below, for the time strictly necessary to achieve the purposes for which they were collected, or, where possible, until the time when the owner of the data should receive your request for cancellation of data whose consent to processing is optional and not required.

Your personal data are, in any case, processed in compliance with the provisions relating to the confidentiality of personal data contained in the Regulation and the Measures issued by the Guarantor Authority.

We use commercially reasonable technical and organizational measures and controls to protect your Personal Information from loss, misuse and unauthorized access..



COMMUNICATION OF PERSONAL DATA

Without prejudice to communications made in compliance with an obligation of law, regulation or Community legislation, your data may be communicated:

- a) to natural and/or legal persons that we use in the execution of the services and for activities related to them;
- b) persons delegated by us and / or appointed to carry out professional and technical maintenance (including maintenance of network equipment and electronic communications networks of websites where the data are published).

In any case, the subjects mentioned will be communicated only the data necessary and relevant to the purposes of the treatment which they are responsible as external managers / appointees of the treatment, appointed by the owner as required by current legislation.

Personal data will therefore not be disclosed.

The Data Controller collaborates with law enforcement agencies and other public bodies and authorities to ensure that its users respect the law, the rights of other users and third parties, including their intellectual property rights. Therefore, your personal data may be communicated, by way of example but not limited to, to public entities, where this is necessary for purposes of defense, state security, prevention, detection or prosecution of crime, in compliance with the rules governing this matter.

These public entities will have the right to request and obtain personal information about you even if this is necessary or appropriate for investigations or investigations relating to the commission of fraud, computer fraud, infringement of intellectual property rights, acts of computer piracy or other illegal activities, which could expose us or our users to legal, civil or criminal liability.

RIGHTS OF DATA SUBJECTS AND EXERCISE OF RIGHTS

In compliance with current legislation, you can request at any time:

1. Confirmation of the existence or not of your personal data;
2. Know the content and origin, purposes and methods of treatment;
3. The logic applied in case of processing carried out with the help of electronic means;

The identification details of the owner, managers and subjects or categories of subjects to whom your personal data may be communicated.

In addition, it is your right to obtain:

1. The updating, rectification, integration, the right to data portability;
2. The cancellation, transformation into anonymous form or blocking of your data processed unlawfully;
3. The opposition in any case, for legitimate reasons, to the processing of data relevant to the purpose of collection.
4. Opposition to the processing of data for commercial purposes.

If the user contacts us and asks us to access his or her Personal Information or to remove it from our systems and records, in compliance with this Privacy Policy and legal obligations, we will do our utmost to grant such a request, within the prescribed time limit.



We inform users that, however, due to technical constraints and due to the backup of their systems, your Personal Information may continue to reside even after deletion for a certain period of time and in part of our systems.

The data controller reserves the right to refuse requests for access to or deletion of Personal Information if the disclosure or deletion of the information requested is not permitted by law.

To protect ourselves from unlawful access requests, we reserve the right to request sufficient information to verify the identity of the party submitting the request.
